- 8. The marks sheet of last examination in original along with attested copies of the same.
- 9. No dues and Conduct certificate from the previous hostel, wherever applicable.
- 10. Domicile certificate (must not be more than 1 year old) OR father's Job ID in case father of applicant is employed with Central/State Government.
- 11. Copies of Voter IDs and Aadhar Cards (after severing Aadhar numbers) of applicant and his parents.
- 12. The financial guarantor document duly signed.

The list is provisional and does not guarantee admission to the Hall. Rankings are subject to change based on departmental merit lists and any necessary corrections. Claims regarding the ranking can be submitted to the Hall Office until Tuesday, 9th September 2025 by 1:00 p.m. Valid claims will be addressed and updated notices will be displayed on the Gwyer Hall notice board by 4:00 p.m. 9-9-2025. The decision of the Admission Committee in this matter will be final. Admissions of Ph.D. candidates are subject to the submission of the BRS letter, joining report, and fee receipt.
