- 5. Character certificate from the Head of Department/Institute last attended. In case of Ph.D. students, character certificate from the respective Head of the Department will be entertained.
- 6. Date of birth certificate/10th Class Certificate.
- 7. Copy of CUET/relevant score card on the basis of which the student has been admitted to the department, wherever applicable.
- 8. The marks sheet of last examination in original along with attested copies of the same.
- 9. No dues and Conduct certificate from the previous hostel, wherever applicable.
- 10. Domicile certificate (must not be more than 1 year old) OR father's Job ID in case father of applicant is employed with Central/State Government.
- 11. Copies of Voter IDs and Aadhar Cards (after severing Aadhar numbers) of applicant and his parents.
- 12. The financial guarantor document duly signed.

The list is provisional and does not guarantee admission to the Hall. Rankings are subject to change based on departmental merit lists and any necessary corrections. Claims regarding the ranking can be submitted to the Hall Office until 3rd October 2025 by 1:00 p.m through physically and email also. Valid claims will be addressed and updated notices will be displayed on the Gwyer Hall notice board by 5:00 pm on 03-10-2025. The decision of the Admission Committee in this matter will be final. Admissions of Ph.D. candidates are subject to the submission of the BRS letter, joining report, and fee receipt.
